MN PRODUCTION REBATE TERMS AND CONDITIONS

These Terms and Conditions constitute a legally binding agreement between the undersigned Production Company ("you" or "your") and Minnesota Film & TV ("MN Film & TV" "we" or "us").

NO GUARANTEE OF REIMBURSEMENT

Submission and/or acceptance of an application or other materials for project certification does not, in any way, guarantee or ensure certification or approval by us. Furthermore, even if a Project is certified, there is no guarantee that you will receive a reimbursement or that reimbursement funds will be available for payment to you.

APPLICATION PERIOD

In order to be considered for reimbursement, expenditures must be incurred no earlier than the project certification date. All forms and applications must be submitted as described in the Program Guidelines and conform to those guidelines as revised by MN Film & TV from time to time, in its sole determination. A copy of the Program Guidelines is attached hereto and made a part hereof.

LIMITATION OF LIABILITY

In no event will MN Film & TV, its officers, directors or employees or agents be liable for lost profits or damages of any kind, including, but not limited to, direct, indirect, special, incidental, consequential or punitive damages, arising out of or in connection with the application, reimbursement, certification, or award process however arising, including negligence.

REPRESENTATIONS AND WARRANTIES OF PRODUCTION COMPANY

You represent and warrant: (1) that all information provided in or with your application is true, accurate and complete and no material information has been omitted, and that any subsequent statements will be true and accurate; (2) that you will provide MN Film & TV with prompt written notice if any past statement is no longer true and accurate; (3) that you have the authority to bind the entity on whose behalf you are signing and that entity is validly formed and in good standing; (4) that the project which is subject to your application (the "Project") is a bona fide feature film, television or Internet program, documentary, or commercial and qualifies under the Program Guidelines; and (5) you have secured all necessary rights for the Project and the Project does not infringe, in whole or part, any statutory copyright or common law, property rights, or other right of others, or any law or regulation.

REQUIRED DISCLOSURES

On a separate piece of paper attached hereto and made a part hereof, the Production Company or any of the principals or owners of the Production Company owning more than 2% ownership interest (the "Subject Parties") must disclose details of their involvement in: a) Any and all filings for bankruptcy protection or protection from creditors; b) Any and all litigation, pending and threatened litigation involving a Subject Party that has or might result in monetary judgment or monetary settlement against the Subject Party or a claim of any nature against the Project; and/or c) Any and all charges, convictions or pleas of nolo contendere (no contest) for any crime, including but not limited to any crime involving obscenity, indecency, or similar misdemeanor or felony laws involving the participation of or victimization of a minor. Upon MN Film & TV's review of the information provided, MN Film & TV may determine in its sole discretion that the applicant is not eligible for reimbursement funds.

INDEMNIFICATION

You agree to indemnify, defend and hold MN Film & TV and its officers, directors or employees and agents, harmless from and against any and all costs, liabilities, losses, and expenses (including, but not limited to, reasonable attorneys' fees) resulting from any and all claims, demands, suits, orders, judgments, liabilities and any and all losses, actions or proceedings for any and all injuries, damages or losses sustained or claimed to have been sustained by any person or entity which arise directly or indirectly, out of a breach or alleged breach of any of your representations, warranties and agreements under this Agreement, including without limitation any arising from false statements or information provided by you. You are aware that the submission of any false information or omission of any pertinent information resulting in the false representation of a material fact may subject you to civil and/or criminal penalties, and you agree in the event of a material breach of this Agreement, in addition to any other remedies available to MN Film & TV at law or in equity, you will immediately repay any and all reimbursements you have received in full.

WAIVER OF CONFIDENTIALITY

All information and materials submitted to MN Film & TV are non-confidential and may be disclosed to third parties by MN Film & TV and may become public. You hereby waive and release MN Film & TV from any claim or obligation relating to the confidentiality or alleged trade secret nature of any materials or information you submit to MN Film & TV. All submitted information is subject to public disclosure per MN Statutes Chapter 13.

RIGHT TO REFUSE

The MN Film & TV application process does not guarantee acceptance for the applicant(s). MN Film & TV reserves the right to refuse any Project's application for any reason whatsoever. Such determination is solely at the discretion of MN Film & TV and all decisions are final and non-negotiable.

NO RETURN OF MATERIALS

Your application and all materials and information submitted with it will become the property of MN Film & TV and will not be returned to you.

GOVERNING LAW

The laws of the State of Minnesota govern this Agreement and any dispute you may have with MN Film & TV, without reference to its laws regarding choice-of-law. You agree that the only proper jurisdiction and venue for any dispute with MN Film & TV is in the State of Minnesota. You further agree and consent to the exercise of personal jurisdiction in these courts in connection with any dispute involving MN Film & TV or its officers, directors or employees.

SEVERABILITY

If any provision of this Agreement is determined to be invalid under any applicable statute or rule of law, such provision or clause is to that extent to be deemed omitted, and the balance of the terms of this Agreement will remain enforceable. MN Film & TV's failure to act with respect to any failure by you or others to comply with this Agreement does not waive MN Film & TV's right to act with respect to similar or subsequent failures.

CHANGES

MN Film & TV may change the terms of this Agreement and/or the eligibility criteria for project certification and the Project Guidelines at any time. All such changes will be immediately binding on you. Changes will be posted on MN Film & TV's website www.mnfilmtv.org.

ARBITRATION

Regarding any claim or dispute brought in connection with this Agreement, MN Film & TV will have the exclusive right to resolve such claim or dispute through binding arbitration held in Minneapolis, Minnesota and governed by the rules of the American Arbitration Association applying the laws of the State of Minnesota.

ASSIGNMENT

You will not have the right to assign this Agreement or any of your/the Production Company's obligations and agreements herein without the written approval of the MN Film & TV, in its sole discretion.
